CALL BOARD TO ORDER

Ms. Jackson called the meeting to order at 6:00 p.m.

NEW BUSINESS

Mr. Eckmann presented the board with a brief overview of the budget committee meeting in which a proposed levy of \$48,466.73 was recommended. This levy will maintain the same programs and expenditures as are currently budgeted. Only the known contractual increases were included in the budget. The floor was opened for public comment. Ms. Davidson felt that the \$80,000 levy was acceptable. She added that the art program was very important to her and many members of the community and she didn't want that to be cut in any way.

Ms. Brandborg led the group in the discussion. Concerns were listed:

- This may not be enough money if costs go up.
- Not all increases may be reflected in the \$48,466.73
- The former number of \$80,000 feels like a really big number.
- Is it any easier to pass a \$50,000 than an \$80,000?
- What happens if the levy fails?
- Within this budget, there is no rainy day money. It is very tight.

Mr. Eckmann moved to proceed with a levy in the amount of \$48,466.73. Ms. Lewis seconded the motion which passed unanimously.

Discussion continued concerning the responsibility of getting the information to voters. According to MCA 2-2-121(3), there are limits on the actions of trustees to promote elections. Keeping those limits in mind, the group brainstormed many ideas and selected several to complete. Each member volunteered for 1 or more.
